**STIPULATION AND [PROPOSED] ORDER PERMITTING
LIMITED PARTICIPATION IN JURISDICTIONAL DISCOVERY**

IT IS HEREBY STIPULATED AND AGREED among the undersigned parties, subject to approval by the Court, as follows:

1. Documents produced under jurisdictional discovery in *Fairholme Funds, Inc., et al. v. United States*, 13-465C (“*Fairholme*”) that are subject to the protective order in that case may be used in *Arrowood Indemnity Company, et al. v.
