DEFENDANT'S UNOPPOSED MOTION TO REOPEN CASE

Defendant PricewaterhouseCoopers LLP (“PwC”) respectfully requests the Court to reopen the above-captioned case. On April 21, 2016, this Court granted PwC's motion to stay this action pending resolution of a motion that the Federal Housing Finance Agency (“FHFA”) filed before the Judicial Panel on Multidistrict Litigation (“JPML”) to consolidate and transfer a number of actions related to the FHFA’s conservatorship over Federal Home Loan Mortgage Association (Fannie Mae) and the Federal Home Loan Mortgage Corporation (Freddie Mac).

(D.E. 11.) In addition to staying the case, the Court directed the Clerk of Court to mark the case closed. The Court retained jurisdiction to restore the case to active status, on motion, in the event of changed circumstances.

On June 3, 2016, PwC notified this Court that the JPML denied FHFA's motion.

Many of the plaintiffs in this case have filed a nearly identical action against Deloitte & Touche LLP ("Deloitte"). *See Master Sgt. Anthony R. Edwards, et al. v. Deloitte & Touche LLP*, 1:16-cv-21221-RNS (S.D. Fla.). That case was also stayed pending resolution by the JPML of FHFA's motion to consolidate and transfer. On June 8, 2016, the Court in the Deloitte case reopened the case in light of the JPML's denial of the FHFA's motion.

Wherefore, PwC respectfully requests that the Court reopen this case.

Undersigned counsel for PwC certifies that counsel for plaintiffs, Stephen Sorensen, has been contacted and has authorized us to represent that he does not object to the relief requested.
