Pursuant to Paragraph 8.1(d) of this Court's General Order No. 11-02 regarding Electronic Case Filing Administrative Policies and Procedures, Plaintiff Arnetia Joyce Robinson hereby moves the Court to unseal her Amended Complaint (ECF 15) and Consolidated Response in Opposition to Defendants' Motions to Dismiss (ECF 30) (the "Response"). The Amended Complaint and Response were originally filed under seal because they contain certain information from documents that are subject to a protective order entered in a case pending in the United States Court of Federal Claims, *Fairholme Funds, Inc. v. United States*, No. 13-465C. The producing parties have since waived the protections of the Protective Order for the portions of the documents that contain the protected information referred to in the Amended Complaint and the Response. Therefore, there is no need to continue to seal the Amended Complaint and the Response. The undersigned has consulted with Defendants' counsel and Defendants do not oppose Plaintiff's request.

In addition, because Plaintiff may be required to refer to certain portions of the Amended Complaint during an oral argument scheduled before the Joint Panel on

Multidistrict Litigation on Thursday, May 26, 2016, in the case of *In re Federal Housing Finance Agency, et al., Preferred Stock Purchase Agreements Third Amendment Litigation*, MDL No. 2713, Plaintiff requests that the Court unseal the Amended Complaint promptly.
