NOTICE OF RELATED CASES

In accordance with Local Civil Rule 40.5(b)(3), defendants Federal National Mortgage Association, Federal Housing Finance Agency, and the Department of the Treasury hereby provide notice that *Voacolo v. Federal National Mortgage Association, et al.*, Civil Action No. 1:16-cv-1324(RC), and *Perry Capital LLC v. Lew, et al.*, Civil Action No. 1:13-cv-1025(RCL), *Fairholme Funds, Inc., et al. v. Federal Housing Finance Agency, et al.*, Civil Action No. 1:13-cv-1053(RCL), and *Arrowood Indemnity Co., et al. v. Federal National Mortgage Association, et al.*, Civil Action No. 1:13-cv-1439(RCL), are related.

The earlier-filed cases, Civil Action No. 1:13-cv-1025(RCL), Civil Action No. 1:13-cv-1053(RCL), and Civil Action No. 1:13-cv-1439(RCL), were coordinated before a single district court, and were dismissed. *See Perry Capital LLC v. Lew, et al.*, 70 F. Supp. 3d 208 (D.D.C. 2014). An appeal of that decision is now pending before the Court of Appeals. *See* No. 14-5243 (D.C. Cir. filed Oct. 8, 2014). The later-filed case, Civil Action No. 16-cv-1324(RC), involves the same defendants and relates to the same subject matter. *See* Compl. ¶¶ 1-6, ECF No. 1.

Indeed, the later-filed case appears to seek to assert claims that were resolved in the original cases. *Compare* Compl. ¶¶ 28-36 with *Perry Capital*, 70 F. Supp. 3d at 219-29. Accordingly, the cases are related under Local Civil Rule 40.5(a)(4).
